1. Booking

Completion, signing, and submission of this contract with a check made out to Steuart Pittman, Jr. for \$200 as a booking fee will confirm a reservation. The booking fee is later applied to the full breeding fee. In cases of multiple mares needing shipped semen or live cover on the same day, priority will be according to how early the booking fee was paid.

2. Breeding Fee

The breeding fee for 2012 is \$1,200. It is due before shipment of semen, or before the mare is removed from Dodon Farm after breeding or insemination. If a booking fee was paid in advance, the balance of \$1000 is due at this time.

3. Negative Uterine Culture

All mares who are to be bred live cover must have proof of a recent negative uterine culture. It is strongly recommended that AI mares also be cultured.

4. Live Foal Guarantee

If this breeding fails to produce a live foal that stands and nurses there is a return privilege available. The owner can re-breed the same mare or another mare that is approved by the stallion owner during the 2013 and/or 2014 breeding season by paying a \$200 booking fee for each year in which the mare is bred. This privilege expires after 2014 unless the stallion owner agrees to an extension. The breeding fee itself is not refundable unless the stallion dies or is no longer fit for breeding, or unless non-viable semen is shipped.

5. Viable Semen Guarantee

If shipped semen arrives within 24 hours of being shipped from Dodon Farm and the mare owner's veterinarian determines that the semen is not viable and the mare does not conceive, the mare owner is entitled to a full refund of both the booking and the breeding fee.

6. Mare Care

If the mare is left at Dodon for breeding there will be a board charge of \$15 per day or \$20 per day for a mare with foal. The mare owner agrees to pay for any veterinary care during this stay, including but not limited to palpations and ultrasound to determine stage of estrous and pregnancy.

7. Transported Semen

Cooled semen will be shipped overnight upon payment of the stud fee and shipping costs. The mare owner will notify the stallion owner when the mare comes in heat and has been palpated or had an ultrasound by a veterinarian. Barring unforeseen circumstances, semen can be sent out on 24 hours' notice. Do not expect us to collect and ship semen on the day that you call.

8. Collection Fees

There are no extra fees for collection of semen unless a mare needs more than one collection in an ovulatory cycle. If a second shipment is requested during a cycle a \$100 collection fee will be due.

9. Liability

Neither the stallion owner nor mare owner, their agents, employees, nor the owners of Dodon Farm are liable for the death, injury, disease or accident caused to or by the stallion, mare, or foal.
